1. Trusts in context

2. Purpose of trusts

- Trusts as channel for SED/ED commitments use and risks

- What role can trusts play in ensuring companies meet the ED requirements?
- Are there more effective and equitable ways of providing benefit to communities that fit within the current regulatory requirements?
- Community trusts as vehicles for community development (potential).

3. Constituting trust structures

- How do you minimise the risk to the trust and the company when community trustees are appointed? Taking cognisance of divisions/factions that exist within the communities

4. Constituting trust work

- Agreeing to a 'CDP'
- How are their activities and initiatives planned?
- Are there community profiles/needs assessments that inform their work?
- The "copy and paste" approach that is sometimes used when dealing with local community needs does not take into account the unique needs of each local community ...

... trust work ...

 How do Trusts balance the immediate needs of the community with long-term, sustainability of funds / positive gains to the community?

5. Governance

- What happens when community trustees are business owners and would like to offer services in the projects?
- Who participates in decisions, how inclusive is their (trust) work?

6. Relationships with community

- How well are local CBOs and NPOs informed of their work?
- Uniqueness [of REIPPPP provisions] means that there is an absence of "off-the-shelf" solutions for trusts which creates on the one hand opportunities (to do it right/in a transparent manner/etc...) and on the other hand might cause misunderstandings/lack of appropriate communication towards communities in certain cases.

7. Supporting operations

- Making them more operational and effective
- The process of getting trustees competent from inception to maturity
- How to keep, comply and retain PBO status and meeting SARS requirements
- Making the trustee back office effective to enable capacity to perform administrative and expert functions
- How to guide and assist non performing trusts to turnaround and perform
